- If swallowed : Do NOT induce vomiting. Immediately rinse mouth and then drink 200-300 ml of water, seek medical attention. Keep respiratory tract clear. Do not give milk or alcoholic beverages. Never give anything by mouth to an unconscious person. If symptoms persist, call a physician.

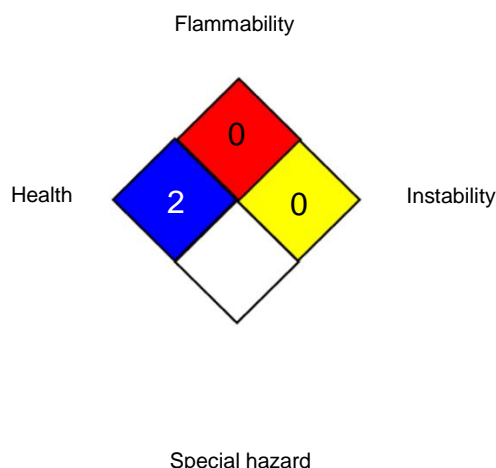
